Application for extension of Schengen visa/stay in Denmark

How to apply

When applying for extension of Schengen visa/stay in Denmark you need to:

- 1. Fill out and sign this form.
- 2. Enclose your passport.
- 3. Enclose nessesary documentation.
- 4. Submit the application in person at the Danish Immigration Service's Citizen Service. You must book an appointment before you show up at the Citizen Service. Read more about where the Immigration Service's Citizen Service has branch offices and how you book an appointment at www.newtodenmark.dk/visit-us.

Please note, the person you are visiting in Denmark must accompany you.

When can you get your Schengen visa extended?

Under certain circumstances, a Schengen visa issued for less than 90 days can be extended to cover a total stay of 90 days. These circumstances could for instance be humanitarian considerations, compelling business or personal reasons. For more information see www.newtodenmark.dk/visa

When can you get your stay in Denmark extended?

In some cases, your visa or visa-free stay in Denmark may be extended by a visitation permit of up to 90 additional days. This can be done with a visitation permit that will extend your stay with up to 90 days. For more information see www.newtodenmark.dk/visa

Which documents must you submit?

You must submit all relevant documents. For instance, if you are applying for an extension due to you being affected by a serious disease, you must submit a medical certificate.

Please note, if you are applying for an extension of your Schengen visa, youmust enclose a copy of your travel medical insurance covering the period you are applying for.

Payment of fee

If you apply for an extension of your visa in up to 90 days per 180 days, you have to pay a fee of 225 kr. to be able to submit your application.

What happens after you have applied for an extension of your Schengen visa/stay in Denmark?

After you, in due time, have applied for an extension of your Schengen visa or stay in Denmark, you have the right to stay in Denmark until the Danish Immigration Service has processed your application.

B. Notification that the Danish authorities have registered information about you and your affairs
The information you supply or have supplied in connection with the application for a visa will be registered in the
Danish Visa Information System IVR-VIS, used by the Danish Immigration Service for visa case processing, and in
the Schengen Member States' common Visa Information System C-VIS. This also applies to information you may give
in conjunction with an application to extend the applicant's stay in Denmark. The registration is mandatory.

Any personal data concerning you which appear on the invitation form will be supplied to the relevant authorities of the Schengen Member States and processed by these authorities, for the purpose of a decision on the visa application. Such data will be registered in IVR-VIS for a maximum period of five years, and in C-VIS for a maximum period of eight years. During this period of time, it will be accessible to the visa authorities and the authorities competent for carrying out checks on visas at external borders and within the Member States. Furthermore, immigration and asylum authorities in the Member States will have access to the data for the purpose of verifying whether the conditions for the legal entry into, stay and residence on the territory of the Member States are fulfilled, of identifying persons who do not or who no longer fulfil the conditions, of examining an asylum application and on

Under certain conditions the data will also be available to designated authorities of the Member States and to Europol (European Union's law enforcement agency) for the purpose of the prevention, detection and investigation of terrorist offences and of other serious criminal offences. You are entitled to right of access to the information registered about you in IVR-VIS and C-VIS and of the Member State which transmitted the data. Inquiries about this can be addressed to the Danish Immigration Service, Farimagsvej 51A, 4700 Næstved, e-mail: visa@us.dk.

You can request that data relating to you which are inaccurate be corrected and that data processed unlawfully be

deleted. If you request it, the authority examining the visa application will inform you of the manner in which you may exercise your right to check the personal data concerning you and have them corrected or deleted, including the related remedies according to Danish nation Law. The national supervisory authority in Denmark (the Danish Data Protection Agency) will consider claims concerning the protection of personal data. C. Information regarding possible verification by the authorities of the information you have supplied The Danish Immigration Service may seek to verify the accuracy of the information you have given in this form. This may happen while the application is being reviewed or after the applicant has been granted a visa. Verification may be conducted at random and is not necessarily an indication that the Danish Immigration Service suspects you of providing false information.

Verification may involve the following:

- Checking public registers, such as the Central Person Register
- · Contacting other authorities, such as municipalities

You may be asked to supply additional information as part of the verification process.

D. Information about the consequences connected to an illegal stay

If you are granted an extension of the visa/stay, you are to leave the Schengen countries within the validity of the new visa. The visa gives you as the holder the right to reside in the Schengen countries for a predetermined number of days within a further defined period of validity. You must leave the Schengen countries or Denmark before the validity period expires.

If you stay in Denmark or in another Schengen country beyond the validity of the visa, it can have serious consequences and you can be given a penalty period. During this period you will normally be unable to obtain a Schengen visa to enter Denmark. If you exceed the visa period by up to 30 days you can be banned for 3 years, and if you exceed the visa period by more than 30 days, a 5 years ban can be imposed.

E. Information about the consequences if the applicant is expelled from Denmark or applies for asylum in Denmark or another Schengen country

If you upon entering Denmark on a visa is expelled either by administrative decision or by court order, or if the you apply for asylum in Denmark or another Schengen country and do not leave voluntarily after the final rejection, you will not be eligible for obtaining a new visa to Denmark for a period of 5 years.

F. Information about possible consequences if the applicant applies for a residence permit while in Denmark on a visa (short term)

Normally, an application for a residence permit is to be submitted from your home country. If you are staying in Denmark on a visa (short term) and submit an application for a residence permit in Denmark, you can become ineligible for a visa for 5 years. During that period, you will normally be unable to obtain a visa to Denmark.

However, the abovementioned consequence does not apply to a variety of different types of residence permits, or if you leave within the validity period of the visa. You can read more about what types of residence permit an applicant can apply for while the applicant is staying in Denmark on a visa, without the applicant being prevented from obtaining a visa, in section 4c of the Aliens Act and on www.newtodenmark.dk/misuse

Please note: If the main purpose of the application for a residence permit is for you to be allowed to remain in Denmark while the case is being processed, although it is evident that a residence permit cannot be granted, you will become ineligible for a visa, even though you normally would be except from being banned.

G. Information about the consequences if the applicant gives birth in Denmark during the visa stay If you give birth in Denmark during the visa stay without having previously made an agreement with a private hospital regarding the birth including payment, you will normally be unable to obtain a visa to Denmark for a period of 3 years.
